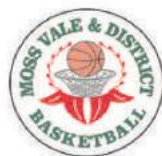

CHAIRMAN'S BNSW REPORT 2016

In my second year of the elected three year term, I am pleased to offer this Report as Chairman on behalf of the 2016 Board of Directors.

The Board elected me as Chairman, for the second consecutive year – an honour for me to lead our great sport in NSW and seek further progress in 'growing' basketball to the levels enjoyed in the last decade.

2016 has been a challenging year for the BNSW Board with strong efforts being made to improve the governance and financial management of the sport, efforts to unify the sport, working closely with all stakeholders both within NSW and Nationally.

The 2016 AGM re-elected Jenny Dean for a further three year term and Laretta Claus was elected to a three year term replacing Fiona Johnson, who chose not to renominate.

In accordance with the Constitution, the Board chose to fill two vacancies with two excellent candidates – a former BNSW President with a distinguished career in sport, business and Not for Profit Organisations – David Brettell and Amanda Truong, a highly qualified and experienced accountant, who has been invaluable in becoming the Chair of the Board Finance and Audit Committee.

The AGM awarded Life membership to William (Bill) Goodman – a remarkable long serving referee.

The Board has met monthly on 11 occasions in 2016 and been well supported by the staff in the preparation and execution of Board Meetings.

In establishing the key priorities for BNSW, the Board established three Working Groups, chaired by a Board member and involving recognised practitioners including staff to provide recommendations to the Board.

a) Membership

Chaired by David Brettell – The challenge is to simplify membership of BNSW to all those interested in playing basketball at whatever level; integrate the many groups into the BNSW Family; supporting BA with an integrated/simplified membership system and National Registration System and creating incentives for Associations to grow their membership etc.

b) Facilities

Chaired by Bob Elphinston – An urgent priority exists for BNSW to engage with Government at all levels to increase funding for the expansion and building of indoor facilities, across the State and in growth areas in particular. BNSW, through consultants, have a detailed Report, funded by the Office of Sport, now before Government outlining the actual facility needs; the Sport seeks a Centre of Excellence and support needs to be given to associations looking to improve their existing facilities; Stadia additions/new facilities moving forward include City of Sydney, Port Macquarie, Shoalhaven, Hills, St George, Manly Warringah, Newcastle, Murwillumbah, Tumut, Queenbeyan, West Wyalong, Moss Vale and Wagga Wagga. Several other Associations are energetically pursuing new/enlarged playing facilities and BNSW remains very committed to supporting these initiatives.

C) High Performance

High Performance – Chaired by Bob McGugan – Success for our players at the highest level is important, but there are many challenges from external parties, hence co-ordination of HP programmes at Association, State and National level is important, as is the best use of funds for the many different ‘elite’ program. An important and long overdue initiative was the signing of an Agreement with the 11 Regional Academies of Sport (RAS), assisted very much by RAS Basketball Coordinator, Ian Robilliard, which will enable a basketball program to be included in all 11 Regional Academies on an annual basis.

Another priority is to encourage greater female participation in all levels of the sport as players, coaches, referees, administrators, technical officials and Lauretta Claus is chairing a Working Group of interested practitioners looking to establish programs and role models in this important area for BNSW.

The Board Committees have taken their responsibilities very seriously, meeting regularly and providing recommendations to ensure the Board is working towards the highest levels of governance and financial management for BNSW, as expected by Government and BNSW Members.

After several ‘false starts’, Lauretta Claus, upon joining the Board, assumed responsibility for developing and finalising the BNSW Strategic Plan, involving Board and staff significantly in the final delivery. BA produced its Strategic Plan and together with the FIBA Strategic Plan, a comprehensive and meaningful document was approved by the Board which will serve the sport well over the next four years.

The BNSW Country Committee under the Chairmanship of Anthony Foy has enjoyed a most active year focusing on development program across the State and across most age groups. John Martin (Secretary) and Richard Boyle (Treasurer) and a significant number of volunteers have served the sport strongly with basketball maintaining its position as a very active participant in Country NSW Sport.

Metropolitan Forums were expanded in 2016 creating a communication and ideas sharing platform for the 19 Metro Associations. A Metropolitan Advisory Committee has been elected and will meet regularly providing advice to BNSW on development opportunities for the growth of basketball in Metropolitan Sydney.

After an extended period of annual leave and sick leave, CEO Daniel Martinez resigned on 3 November, 2016. The Board has acknowledged the long and committed service of Daniel.

A transparent public recruitment process through Sportspeople P/L attracted 81 candidates and following shortlisted interviews by a Board Sub Committee, Maria Nordstrom was appointed by the Board for a five year term commencing 2 February, 2017. Maria brings a great combination of an extensive basketball involvement and a highly successful business career supported by an engaging personality and a burning desire ‘to grow the game of basketball, her sporting love,’ to record levels in NSW. The Board and staff look forward to delivering a new focus and higher level of service to our stakeholders led by CEO Maria Nordstrom.

Part time Financial Consultant, Graeme Reid, resigned his role in May, 2016 with BNSW to take up a full time role as CEO of Northern Suburbs Basketball Association. We thank Graeme for his good service to BNSW.

Following a public recruitment process, Caroline McLuckie, a fully qualified and experienced accountant, was appointed in September, 2016, giving BNSW a full time General Manager Finance for the first time. Caroline has done a remarkable job in managing the finances and working with the Board Finance and Audit Committee.

Financially in 2016, we have seen success in the basketball specific areas as well as 'off the court', which has further strengthened our balance sheet.

There has been increased participation, well above expectation, in the Waratah Senior Leagues and the Talented Athlete Program, whilst we have been able to keep costs to a minimum over all the domestic competition and high performance areas.

The Aussie Hoops program has seen incredible traction beyond any predictions with increased revenue, but also keeping the costs as low as possible to encourage participation.

Despite reduced grants in the high performance area, the change from an intensive Training Centre focus to a High performance program has seen higher levels of player attendance.

The BNSW owned Office property at Homebush has been revalued reflecting an increase in value.

The establishment of a Capital Loan program to assist Associations needing to invest or upgrade in essential equipment (lighting, scoreboards, backstops etc) will be accelerated in 2017.

In seeking to improve the governance of BNSW, the Board agreed to seek a new Auditor (the previous Auditor had been in the same role for more than 15 years) and under the guidance of Jenny Dean, tendered the role leading to the engagement of Carl Dumbrell (DFK Laurence Varney). Carl and his key staff subsequently formed a new Company, Catalyst Partners and have proved to be a major asset to BNSW, providing highly professional services and guidance.

Following the retirement as a staff member of BNSW, on 31 December, 2015, Kim Murphy, continued in his role as Company Secretary until the 2016 AGM. The Board subsequently appointed Ian Fullagher of Lander and Rogers Legal as Company Secretary including the provision of essential legal support for the 2016 year, with the Agreement concluding on 31 Dec, 2016.

The Board is very appreciative of the excellent work undertaken by a small, but dedicated staff working out of the BNSW owned premises in Homebush on the edge of Olympic Park. We thank Kim Murphy for his great support as 'Office Coordinator' following the departure of the CEO in the second half of 2016.

The Sydney Kings organisation rented office space from BNSW, but with the Ogden Group taking over the ownership of the Sydney Kings NBL Club, the Kings have relocated to office space within the QUDOS Arena, their new playing arena in Sydney Olympic Park.

BNSW entered into a financially beneficial agreement with the Sydney Kings, with financial support being provided to the 19 Metro Associations aimed at 'growing the game' in Sydney and in turn attracting greater attendances at the SK home games.

BNSW continues to seek avenues of support in working with the Sydney Flames WNBL Club and the Illawarra Hawks NBL Club, who enjoyed a most successful Finals program in March, 2016.

BNSW has been an active participant in Basketball Australia activities and meetings providing strong support to the BA Board's initiatives to recover BA's financial position, the introduction of a National Registration System, the revamping of BA High Performance program (which has included less financial support to the States), Aussie Hoops, higher levels of governance and significantly improved communication channels.

In supporting the subsidiaries of BNSW where BNSW has a financial interest, BNSW Board members have been appointed to the respective Subsidiary Boards and regular Board Meetings held to help improve the governance of these subsidiaries and protect the BNSW financial interests.

Horizons Sports and Educational Tours (HSE), where BNSW is the majority owner, continues to operate successfully in a very competitive environment and we are appreciative of Michael Edwards, CEO and minority shareholder, for his energetic efforts to grow the business and provide increased financial returns to BNSW.

BNSW Education has operated successfully during 2016 bringing in increased student numbers and we are indebted to Head Coach Peter Lonergan and his staff for their efforts to grow the business, find employment opportunities for a growing band of talented young boys and girls through basketball and support BNSW Coaching initiatives.

Stadium Sports Management (SSM) has the management rights to Minto and Coffs Harbour Stadia and is always seeking new management opportunities. Our thanks to Glenn Gooding, SSM Manager, for his professionalism and enthusiasm in managing this business. Regrettably Glenn resigned from SSM in Dec, 2016 to pursue other business interests and his replacement is being recruited in early 2017. BNSW has a 50% interest in IFMG which has the management rights to Port Macquarie Stadium, which has recently been expanded to 6 indoor courts and support facilities.

BNSW enjoys financial support from the NSW Government Office of Sport and is appreciative of the special grants and advice received from the previously known NSW Dept of Sport and Recreation. Sports Minister Stuart Ayres has been a good supporter of BNSW and its activities.

Basketball is now positioned to make significant progress in 2017 with renewed levels of management and a willingness of all stakeholders across NSW to work together to grow the sport. Finally, thanks to the many thousands of volunteers who give their time willingly every week to coach, referee, score, manage and support the thousands who enjoy playing basketball.

HIGH PERFORMANCE

HIGH PERFORMANCE

The Basketball NSW Coaching Department introduced a new structure to our development programs and performance pathways in 2016. Through rebranding and revamping our development programs to include the State Performance Program (SPP) and the Developing Athlete Program (DAP), the department was able to add an additional tier to the performance pathway (DAP) thus creating over 250 additional opportunities for athletes and over 50 opportunities for coaches with regards to development and talent identification in NSW that previously haven't been available.

A partnership that was formed with the Regional Academies of Sport (RAS), allowed the department to be able to deliver the DAP to regional areas all across the state.

The ability to attract new players and coaches to our sport remains paramount to Basketball NSW and the Coaching Department and through the many programs that are offered we continue to provide development opportunities for both coaches and players.

DEVELOPMENT PROGRAMS

Some of the programs that the Basketball NSW coaching department offer are:

DEVELOPMENT LEAGUE

The Development League (D League) that started in 2012 continued in 2016 and included over 250 athletes and 72 coaches. It allows male and female athletes and coaches from across the whole state to play with and against players and coaches that they might not normally be exposed to over a four-week period.

TALENTED ATHLETE PROGRAM (TAP)

Basketball NSW once again conducted the Talented Athlete Program (TAP) for Country and Metropolitan Under 14 & Under 15 athletes in 2015. The program is run in conjunction with the NSW Office of Sport and Recreation and the Sydney Academy of Sport.

The program is operated at the Sydney Academy of Sport's facility at Narrabeen and involves an intensive three-day camp, which includes on court sessions, sports science, education and strength and conditioning programs.

The camp brings together some 230 male and female athletes from the NSW country and Sydney Metropolitan areas in the Under 14 & 15 age groups.

DEVELOPING ATHLETE PROGRAM (DAP)

The Developing Athlete Program (DAP) is the first tier of the Basketball NSW High Performance Program. From the athletes perspective there is a strong focus on the identification, development and support of individuals aged 13-17.

The Developing Athlete Program also serves - as platform to develop and educate aspiring elite coaches. Basketball NSW provides expert coaching with elements of mentoring, training, education and support.

DEVELOPMENT TOUR/ TOURNAMENTS

Basketball NSW competes in a number of development competitions, with a focus on providing athletes and coaches opportunities to play against their peers from other states and regions.

These development events provide a valuable link from our development programs to competitive opportunities and also provide our members with a pathway to state teams and participation at National Junior Championships.

COACH DEVELOPMENT

Coach Development was identified as a key area for 2016 and many initiatives were put in place to ensure our coaching network received the up skilling and personal development that they need.

At each camp there is in built sessions for the coaches to learn and engage in dialogue about the technical aspects of coaching as well as seminars on Safe Coaching practices from the Head of High Performance- Coach Development, Peter Lonergan; Nutrition and Strength & Conditioning from BNSW's Head of Strength & Conditioning, Rob Harb and an on court clinic from Australian Opals Assistant Coach Damian Cotter on Running and Effective Practice.

Coaching clinics were also held including a Decision Making clinic run by Peter Lonergan and Director of Coaching at the Australian College of Sport (ACS), Robbie McKinlay and with the support of the BNSW Country Committee, Basketball NSW through the CDP engaged in a series of regional coach development clinics and seminars throughout the state.

COACH EDUCATION

The continuing education of NSW coaches remains a focus of Basketball NSW and this is done through the formal education courses overseen by the National Coach Accreditation Scheme (NCAS) Club Coach (formerly Level 1) and Association Coach (formerly Level 2). In 2016 BNSW accredited 400 Club Coaches and 100 Association Coaches.

EVENTS & COMMUNITY GROWTH

Basketball remains the second highest team participation sport in Australia with more than 1.1 million people playing our great game in Australia. Whilst we know the number of registered participants in NSW has remained the same for the past few years, we know that the number of people playing basketball in the State of NSW is much higher.

Two working groups Female Participation and Membership were formed late last year following the success of the Community Growth Forum. These two working groups act as an advisory body to Basketball NSW Board and Staff on matters concerning Growth and Inclusion. These working groups provides a forum for positive input by Associations to the priorities of growth ambitions of BNSW as reflected in the strategic plan.

The principle aims of these working groups is to utilise the expertise and diverse community knowledge to develop specific growth and inclusion action plans for implementation by BNSW in order to build greater numbers participating in the sport of basketball in NSW.

COMMUNITY GROWTH FORUM

The BNSW 2016 Community Growth, held in October this year at the Figtree Conference Centre and was well attended with more than 70 people attending. The forum focused on U12's basketball, increasing girl's participation in basketball as players, coaches, and referees and developing a positive culture at your association.

AUSSIE HOOPS

Aussie Hoops is Basketball Australia's official junior development program for 10-15 year olds, in 2016 we had 44 centres delivering Aussie Hoops with 4900 participants completing the program, which is an increase of 172% from 2015.

Every new participant received an Aussie Hoops pack, containing a branded singlet, basketball and backpack.

In 2015 Basketball Australia announced Vicinity Centres as the naming rights partners for the Aussie Hoops Program. Vicinity Centres conducted a number of activations at their shopping centres in NSW, with 2435 children and their parents being exposed to Aussie Hoops.

- Warriewood in July – 908 kids (2 activations)
- Bankstown in July – 647 kids

SPORTING SCHOOLS

Sporting Schools is a \$100 million Australian Government initiative designed to help schools to increase children's participation in sport, and to connect children with community sport.

In partnership with more than 30 National Sporting Organisations (NSOs), Sporting Schools will help to coordinate sporting organisations, coaches and teachers to deliver sport before, during and after school hours.

In 2016 the number of schools in NSW that chose basketball as one of the sports to be delivered was 159 in total, with 12,043 participants going through the program, which is a 187% increase from 2015.

The Sporting Schools programs is underpinned by the quality assurance provided by the NSOs, and importantly, the programs are free to families.





MOLTEN WARATAH LEAGUE

The 2016 Molten Waratah League season was once again a season to remember. Teams came from across the state to take part in the seven divisions. The 2016 season saw the number of associations grow and the number of teams entered grow by six. Over a twenty week regular season, all roads led to Terrigal for the 2016 season Final's Weekend on August 13th and 14th. Twenty eight of the top teams across the seven divisions took part in semi-finals on Saturday, with the winners progressing to the Grand Finals on Sunday. Throughout the weekend more than 1000 spectators walked through the doors over both days, to watch and support the top teams. Live Streaming was also very successful for finals games on the Sunday.

As we continue to strive for greatness towards growing and developing our league, we went above and beyond to provide our league members the best that basketball has to offer. Our competition has come alive through our website, live stats, social media and local media coverage, along with players who are making a name for themselves and are also contributing to the growth of Basketball in Australia.

The 2016 Molten Waratah League season saw Basketball NSW implement changes throughout the league to improve the quality, coverage and communication of our league to our stakeholders.

FIBA LiveStats was used for the Championship League and Stadium Scoring was utilised for all other divisions. This allowed for quicker results for all to see on our website.

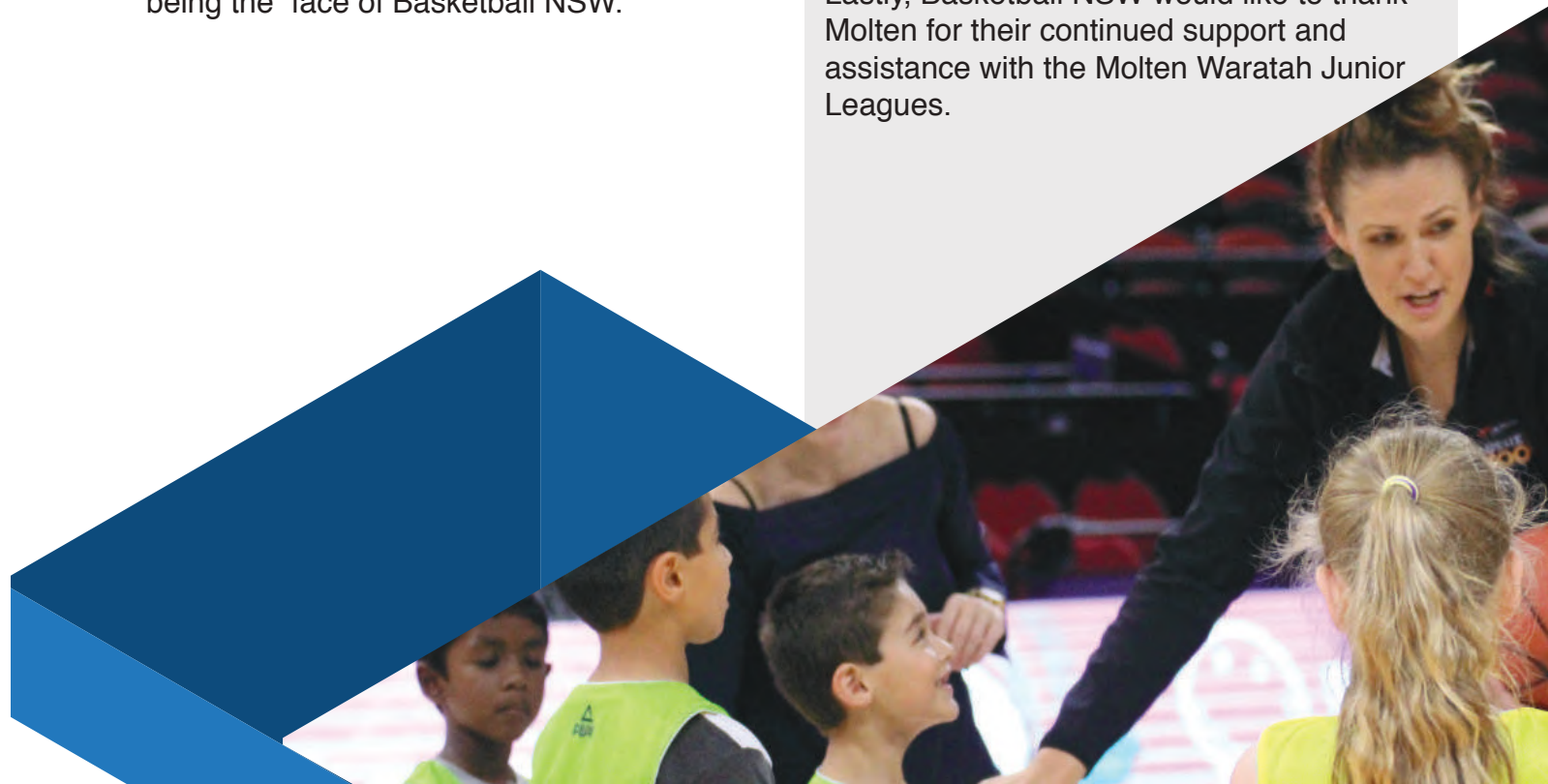

EDUCATION & DEVELOPMENT

Referee, Scoretable and Statistician education has continued to be a high priority for Basketball NSW, with a large number of courses conducted throughout the year.

Basketball NSW has also undertaken during the year to prepare a video for scoretable education for all associations and parents, which was released early in 2017. Basketball NSW has been very pro-active in upskilling a large number of Statistics Officials to a FIBA grading, thanks to Laurretta Claus, Trish Nicholls and Lesley Steel. Basketball NSW will continue to promote and upskill our stats community, with new education material being released during early 2017.

2016 saw several Stats officials upgraded as well as many of our scoretable community being assessed and upgraded at the Waratah League Senior Finals.

In addition to courses, Basketball NSW staff and volunteer educators were present at development events to provide in-game training and assessment to up and coming referees.

Australian Country Junior Basketball Cup, Country Development Tour, East Coast Challenge, Jamborees and D-League are very popular events for those officials looking to advance their skills.

In 2016 an additional referee education concept, "Referee Academy" program was introduced to bridge the gap for Level 1 Referee education, on court work, basic conflict management and practical in game footage/feedback. This program was delivered in Metro and in the country at the CDT, forming the majority of the educational material for this tournament and the D League.

SRDP, the State Referees Development Program, was led by WNBL Referee Rebecca Brockway with assistance from Guy Richards and Logan Bilby. 16 officials were selected to be a part of the program. These officials received both group and one-on-one training sessions and primarily worked our Metropolitan Division 1 competition, Country Premier League and Youth League and Division 1 women's competitions. Some of these officials have been very successful in their representation for NSW at Australian Junior Championships.

In 2016 a new development program was launched (this will replace the SRDP). The JDP (Junior Development Program) will have 2 groups. Group 1 will be sourced through associations, who will each nominate for 2/3 officials working at U16/U18 level to be identified for additional education and development from Basketball NSW staff and network educators to assist them to improve and be developed for senior level competition. Group 2 will be formed from our talented officials progressing from Group 1 into the Australian Junior Nationals arena.

This program will be developed further and then run the full season in 2017. ERP (formerly the NRDP) was led by WNBL Referee Shahrad Shafaghi and former NBL Referee Roger Shiels, 11 officials were a part of this program. Just like the SRDP program, these officials received both group and one-on-one training and primarily worked our senior league games and represented NSW at Australian Junior Championships very successfully.

Throughout the 2016 representative season, Basketball New South Wales has seen a decrease in the overall number of tribunals being held in comparison to the 2015 season. During the 2016 season we had a combined total of 18 Basketball NSW sanctioned tribunals held between March and September as opposed to the combined total of 27 held during the 2015 season between the months of February and August.

During both 2014 and 2015 there were more tribunals held for the Senior League competition as opposed to the Junior League competition. However the 2016 season saw a large decrease in Senior League tribunals and a small increase in Junior League tribunals.

Country Committee

2016 was a successful year for the BNSW Country Committee. A number of new initiatives were introduced as well as continued improvement for our long-standing development programs. Some of these new initiatives included the introduction of the Country Grants Program and the inclusion of non-country associations in the Country Tournament.

Country **Development Program** (CDP)

The CDP camps offer an invaluable opportunity for country athletes and coaches to further develop their basketball knowledge and skills, build personal character strengths and foster lifelong friendships. During 2016, camps were conducted in many country areas including Griffith, Moss Vale, Port Macquarie, Tamworth, Gosford and Maitland. Over 430 athletes representing 28 associations attended the four day camps.

Country **Development Tournament** (CDT)

The CDT is a development tournament for our under 15 and under 17 athletes and was again conducted in Newcastle during January 2017. For the first time at this tournament our country teams were joined by metropolitan teams, and this proved to have an immediate impact on the standard and competitiveness of the tournament. Plans are underway to increase the number of metro teams for next year's event with the possibility of teams from interstate joining the event in the near future.

Australian **Country Junior Basketball Cup** (ACJBC)

The “Cup” (ACJBC) continues to be the premier event for Country teams in Australia. 14 teams attended this years event and NSW Country managed to win gold medals in the under 14 girls, under 16 girls and under 18 boys age groups.

This was the third consecutive year that we have sent three teams in both the under 14 boys & girls age groups and it is pleasing to see that our teams still remain very competitive.

We are looking forward to the introduction of a shorter format and tournament duration for next years event.

Under 12 Skills Days & Jamboree

Our annual under 12 skills days were held in 11 country venues across the state including Merimbula, Moss Vale, Albury, Bathurst, Griffith, Queanbeyan, Terrigal, Tamworth, Port Macquarie, Byron Bay, and Newcastle. The program proved exceptionally popular with 436 athletes attending the development days looking to develop their fundamental skills and form new friendships.

The Jamboree was held in Tamworth’s first class Regional Sports Stadium, coupled with Farrar Agricultural College accommodation helps provide the perfect setting for this iconic event. In 2016, 250 participants including players, coaches, referees and officials attend this four day event.

Country **Tournament**

The newly formed elite premier division allowed non-country based teams to compete at the country tournament. This provided opportunity for our country teams to compete against opposition not commonly faced. Our country tournament was fortunate to have teams enter from Penrith, Hornsby, Bankstown and the ACT. In 2016, all championships were retained by country associations.

In 2017, we are looking forward to even more NSW metropolitan and interstate teams competing at this tournament.

Country Grants Program

In 2016, the committee introduced the “Richard Boyle Country Grants Program” named in honour of the long serving Country Committee Treasurer Richard Boyle.

After a long period of disciplined financial management by current and former committee members we have found ourselves in a position where we are able to assist country associations financially with projects that are designed to grow and develop the game of basketball. The grants are offered on a dollar for dollar basis and can be used for infrastructure projects, development programs or administration development.

In 2016 a total of \$14,000 was awarded to projects by the Barrengarry Conference, Murwillumbah B.A., Maitland B.A and Newcastle B.A.

We look forward to assisting more associations in 2017

These initiative and much more will continue in the coming year to further increase our growth and marketability.



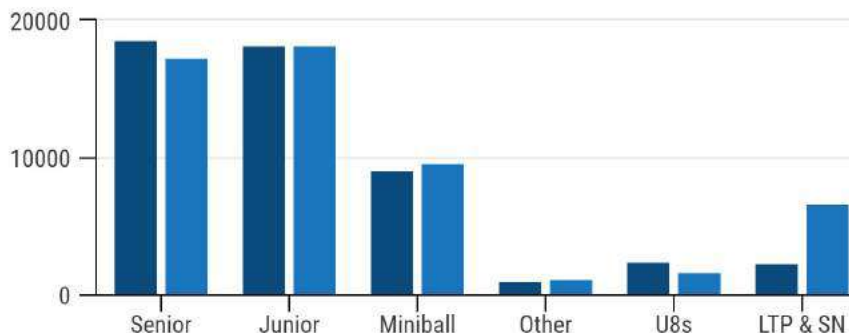

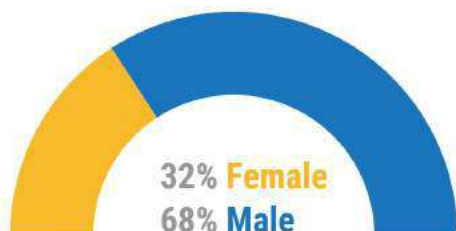

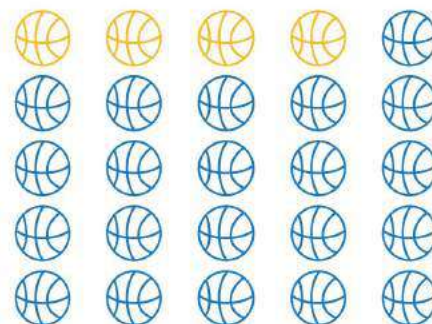
Member Numbers 2015 v 2016

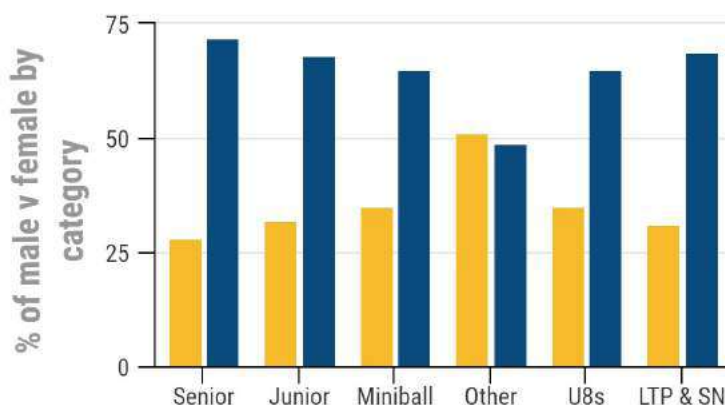

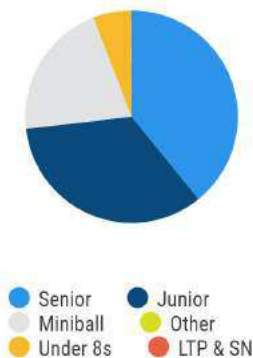
Country Members 2015 v 2016



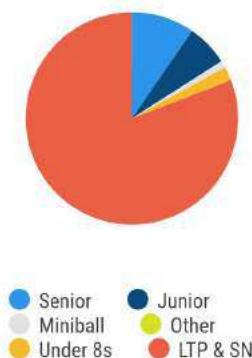
Metro Members 2015 v 2016

The consolidated financial report covers New South Wales Basketball Association Ltd and its controlled entities ('the Group'). New South Wales Basketball Association Ltd is a not-for-profit Company limited by guarantee, incorporated and domiciled in Australia.

Each of the entities within the Group prepare their financial statements based on the currency of the primary economic environment in which the entity operates (functional currency). The consolidated financial statements are presented in Australian dollars which is the parent entity's functional and presentation currency.

The financial report was authorised for issue by the Directors on 14 March 2017.

Comparatives are consistent with prior years, unless otherwise stated.

1 Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with the Australian Accounting Standards - Reduced Disclosure Requirements and the *Corporations Act 2001*.

2 Summary of Significant Accounting Policies

(a) Basis for consolidation

The consolidated financial statements include the financial position and performance of controlled entities from the date on which control is obtained until the date that control is lost.

Intragroup assets, liabilities, equity, income, expenses and cashflows relating to transactions between entities in the consolidated entity have been eliminated in full for the purpose of these financial statements.

Appropriate adjustments have been made to a controlled entity's financial position, performance and cash flows where the accounting policies used by that entity were different from those adopted by the consolidated entity. All controlled entities have a June financial year end.

A list of controlled entities is contained in Note 24 to the financial statements.

Subsidiaries

Subsidiaries are all entities (including structured entities) over which the parent has control. Control is established when the parent is exposed to, or has rights to variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the relevant activities of the entity.

Associates

Interests in associates, where the investor has significant influence over the investee, are accounted for using the equity method in accordance with AASB 128 *Investments in Associates and Joint Ventures*. Under this method, the investment is initially recognised as cost and the carrying amount is increased or decreased to recognise the investor's share of the profit or loss and other comprehensive income of the investee after the date of acquisition.

(b) Income Tax

The Company is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

(c) Leases

Lease payments for operating leases, where substantially all of the risks and benefits remain with the lessor, are charged as expenses on a straight-line basis over the life of the lease term.

Lease incentives under operating leases are recognised as a liability and amortised on a straight-line basis over the life of the lease term.

(d) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Group and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

All revenue is stated net of the amount of goods and services tax (GST).

Sale of goods

Revenue is recognised on transfer of goods to the customer as this is deemed to be the point in time when risks and rewards are transferred and there is no longer any ownership or effective control over the goods.

Grant revenue

Grant revenue is recognised in the consolidated statement of profit or loss and other comprehensive income when the entity obtains control of the grant, it is probable that the economic benefits gained from the grant will flow to the entity and the amount of the grant can be measured reliably.

When grant revenue is received whereby the entity incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction and the grant revenue is recognised in the consolidated statement of financial position as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

New South Wales Basketball Association Ltd receives non-reciprocal contributions of assets from the government and other parties for zero or a nominal value. These assets are recognised at fair value on the date of acquisition in the consolidated statement of financial position, with a corresponding amount of income recognised in the consolidated statement of profit or loss and other comprehensive income.

Interest revenue

Interest is recognised using the effective interest method.

Dividend revenue

Dividends are recognised when the entity's right to receive payment is established.

(d) Revenue and other income continued

Rendering of services

Revenue in relation to rendering of services is recognised depending on whether the outcome of the services can be estimated reliably. If the outcome can be estimated reliably then the stage of completion of the services is used to determine the appropriate level of revenue to be recognised in the period.

If the outcome cannot be reliably estimated then revenue is recognised to the extent of expenses recognised that are recoverable.

Rental income

Investment property revenue is recognised on a straight-line basis over a period of the lease term so as to reflect a constant periodic rate of return on the net investment.

Subscriptions

Revenue from the provision of membership subscriptions is recognised on a straight line basis over the financial year.

Other income

Other income is recognised on an accruals basis when the Group is entitled to it.

(e) Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payable are stated inclusive of GST.

The net amount of GST recoverable from, or payable to, the ATO is included as part of receivables or payables in the consolidated statement of financial position.

Cash flows in the consolidated statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

(f) Inventories

Inventories are measured at the lower of cost and net realisable value. Cost of inventory is determined using the first-in-first-out basis and is net of any rebates and discounts received.

Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the costs necessary to make the sale. Net realisable value is estimated using the most reliable evidence available at the reporting date and inventory is written down through an obsolescence provision if necessary.

(g) Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment.

Items of property, plant and equipment acquired for nil or nominal consideration have been recorded at the acquisition date fair value.

Where the cost model is used, the asset is carried at its cost less any accumulated depreciation and any impairment losses. Costs include purchase price, other directly attributable costs and the initial estimate of the costs of dismantling and restoring the asset, where applicable.

Land and buildings

Land and buildings are measured using the cost model.

Plant and equipment

Plant and equipment are measured using the cost model.

Depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a diminishing value basis over the assets useful life to the Group, commencing when the asset is ready for use.

At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

(h) Financial instruments

Financial instruments are recognised initially using trade date accounting, i.e. on the date that the Group becomes party to the contractual provisions of the instrument.

On initial recognition, all financial instruments are measured at fair value plus transaction costs (except for instruments measured at fair value through profit or loss where transaction costs are expensed as incurred).

Impairment of financial assets

At the end of the reporting period the Group assesses whether there is any objective evidence that a financial asset or group of financial assets is impaired.

Financial assets at amortised cost

If there is objective evidence that an impairment loss on financial assets carried at amortised cost has been incurred, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the financial assets original effective interest rate.

(h) Financial instruments continued

Impairment on loans and receivables is reduced through the use of an allowance accounts, all other impairment losses on financial assets at amortised cost are taken directly to the asset.

Subsequent recoveries of amounts previously written off are credited against other expenses in profit or loss.

Available-for-sale financial assets

A significant or prolonged decline in value of an available-for-sale asset below its cost is objective evidence of impairment, in this case, the cumulative loss that has been recognised in other comprehensive income is reclassified from equity to profit or loss as a reclassification adjustment. Any subsequent increase in the value of the asset is taken directly to other comprehensive income.

(i) Intangibles

Goodwill

Goodwill is calculated as the excess of the sum of:

- i) the consideration transferred;
- ii) any non-controlling interest; and
- iii) the acquisition date fair value of any previously held equity interest;

over the acquisition date fair value of net identifiable assets acquired in a business combination.

The value of goodwill recognised on acquisition of each subsidiary in which the Group holds less than a 100% interest will depend on the method adopted in measuring the aforementioned non-controlling interest. The Group can elect to measure the non-controlling interest in the acquiree either at fair value ('full goodwill method') or at the non-controlling interest's proportionate share of the subsidiary's identifiable net assets ('proportionate interest method'). The Group determines which method to adopt for each acquisition.

Under the 'full goodwill method', the fair values of the non-controlling interests are determined using valuation techniques which make the maximum use of market information where available.

Goodwill on acquisitions of subsidiaries is included in intangible assets. Goodwill on acquisition of associates is included in investments in associates.

Software

Software has a finite life and is carried at cost less any accumulated amortisation and impairment losses. It has an estimated useful life of between one and three years.

Amortisation

Amortisation is recognised in profit or loss on a straight-line basis over the estimated useful lives of intangible assets, other than goodwill, from the date that they are available for use.

Amortisation methods, useful lives and residual values are reviewed at each reporting date and adjusted if appropriate.

(j) Cash and cash equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

Bank overdrafts also form part of cash equivalents for the purpose of the consolidated statement of cash flows and are presented within current liabilities on the consolidated statement of financial position.

(k) Employee benefits

Provision is made for the Group's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

3 Critical Accounting Estimates and Judgments

The directors make estimates and judgements during the preparation of these Consolidated financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

Key estimates - impairment of property, plant and equipment

The Group assesses impairment at the end of each reporting period by evaluating conditions specific to the Group that may be indicative of impairment triggers. Recoverable amounts of relevant assets are reassessed using value-in-use calculations which incorporate various key assumptions.

Key estimates - fair value of financial instruments

The Group has certain financial assets and liabilities which are measured at fair value. Where fair value has not able to be determined based on quoted price, a valuation model has been used. The inputs to these models are observable, where possible, however these techniques involve significant estimates and therefore fair value of the instruments could be affected by changes in these assumptions and inputs.

Key estimates - revenue recognition - long term contracts

The Group undertakes long term contracts which span a number of reporting periods. Recognition of revenue in relation to these contracts involves estimation of future costs of completing the contract and the expected outcome of the contract. The assumptions are based on the information available to management at the reporting date, however future changes or additional information may mean the expected revenue recognition pattern has to be amended.

Key estimates - receivables

The receivables at reporting date have been reviewed to determine whether there is any objective evidence that any of the receivables are impaired. An impairment provision is included for any receivable where the entire balance is not considered collectible. The impairment provision is based on the best information at the reporting date.

Control assessment

The Company is an equal shareholder in IFMG Holdings Pty Limited and owns 50% of the voting interest. The other shareholder owns 50% of the voting interest. Based on the voting patterns and power able to be exerted by New South Wales Basketball Association Ltd, management has determined that IFMG Holdings Pty Limited is not controlled by New South Wales Basketball Association Ltd and therefore has been accounted for as an associated entity.


